

PRIVACY POLICY - INFORMATION ABOUT COOKIES

Dear user,

Cookies are small text files that the sites visited by the user send to their terminal where they are stored to be retransmitted to the same sites at the next visit of the same user.

In addition to cookies sent from the website you are visiting, in some cases, in the course of navigation, you may be able to send cookies to different sites or web servers. In this case we talk about third party cookies.

The purposes of using cookies are various, for example:

- execution of computer authentication,
- session monitoring,
- storing specific information.

Cookies sometimes come up as technically necessary, so you think if they allow you to keep your identity end in procedures with high security standards.

From the point of view of the treatment of personal data, the relevance of cookies is related to the fact that some of them may remain stored in the user terminal even for long periods and may have associated a unique identifier. This code allows you to track user visits and navigation within the site and use the information so acquired for statistical or advertising purposes.

Cookies instead of running their function within a single visit to the site are called session cookies.

Italian law provides cookies in principle for c.d. rule. Opt-in, that is, that can be used by the site vis-à-vis the user who only navigates to you with his consent.

Except for cookies used only for the purpose of transmitting a communication on an electronic communications network or to the extent strictly necessary for the information society service provider explicitly required by the subscriber or user to provide such service. This last type of cookies that make exception to the rule of the cd. Opt-ins are called technical cookies. They can be used freely, even without the consent of the user, but a specific information is required.

For example, they are cookies for which you do not need to collect the customer's prior informed and informed consent:

- 1) cookies implanted in the user's terminal / contractor directly from the individual web site holder, unless they are used for further purposes;
- 2) cookies used to statistically analyze site visits / visits (c.d. cookies analytics), if they only have statistical purposes and collect aggregate information; In this case, however, the site should provide clear and adequate information and provide users with easy ways to oppose (c.d. opt-out) to their facility.

Therefore, except for the case of technical cookies, the general rule is that of prior consent, information or opt-in (c.d. opt-in). The use of technical cookies is strictly forbidden, forbidden or preventive and suitable for information purposes, while for cookies, although no prior and informed consent is required, you must be able to opt-out.

THE COOKIES USED BY THIS SITE

The site you are browsing uses cookies, that is to say, as you have seen text files that sites visited by the visitor send to their terminal, where they are stored and then retransmitted to their sites at any subsequent visit. The present is an information, also made pursuant to art. 13 of the Privacy Code (Law No. 196/2003), concerning the cookies used by the site.

This site does not use cookies for profiling or marketing purposes, but only technical cookies or analytics, some with expiration at the end of the session, others with longer deadlines. In some cases, these are cookies generated by a third-party server (third-party cookies), based on agreements with Mechanical Construction Lupi S.r.l.

THE APPLICATION MODES FOR THE USE OF COOKIES

Although blocking cookies may lead to the inability to enjoy the features of the visited site, the user may object to the use of cookies by the site on his or her terminal. This can be the case, for example, by operating in one of the following ways, by using the most common internet browsers (Internet Explorer, etc.):

1. opt for anonymous / confidential navigation, or
2. Application-specific (cd-plug-ins) computers, ordinarily free and available on browser maker sites, which allow the management and deactivation of cookies used by websites (eg, to prevent Google Analytics from collecting data on your Browsing, you can download the browser add-in at: <https://tools.google.com/dlpage/gaoptout>), or
3. Set your browser in the sense of not allowing cookies to be stored.

In normal cases, with options 2) and 3), you can select between types of allowed cookies (eg not allowing third-party cookies).

All three modes can be disabled at any time and freely by the user.

Below you will find some operational details on how to change cookie settings on some of the most commonly used browsers.

Microsoft Internet Explorer:

Click on the 'Tools' icon (currently in the form of a gear wheel) in the top right corner of the homepage and in the drop-down menu that opens, select the 'Internet Options' option. In the next window that appears, select the 'Privacy' label, where you can choose which cookie settings you want.

Google Chrome:

Click on the Chrome menu (currently in the form of three overlapping horizontal lines) in the top right corner of the homepage, choose the "Settings" option, and at the bottom of the page that opens, click "Show Advanced Settings" . In the "Privacy" section that you add to the page, click on "Content Setup" and, in the "Cookie" section, you can choose the appropriate setting.

Mozilla Firefox:

Click on the Menu (currently in the form of three overlapping horizontal lines) at the top of the homepage, choose the "Settings" option and then the "Privacy" panel, where you can choose the settings for the desired cookies.

Safari:

In the drop down menu in the top right corner of the homepage, click on "Preferences" and from the Privacy panel you can choose to block cookies.
